Tail w/400 sks Class H w/additives. Mixed @ 15.6#/g w/1.18 yd. Plug down @ 5:15 PM 10/12/14. Circ 25 sks of cement to the pit. Tested csg to 7500#. Set wellhead slips w/180k. Tested csg spool pack-off to 3500#. At 12:30 PM 10/14/14, tested BOPE & csg to 2500# for 30 minutes, held OK. Drilled out with 6 1/8" bit.
