This is to notify that this well was pressure tested on 4/5/2013 (NMOCD was notified 48 hours prior). The well failed and was immediately shut-in. The well was scheduled for a workover (also scheduled with the NMOCD). Jesse Madrid contacted this office this morning to notify that the well apparently has a shallow casing leak.

7/22/14:
Set bridge plug @ 1,260 feet; dug around well - located hole in 5 1/2" casing 9 feet from ground surface & 2' above top of surface pipe. Cut off 5 1/2" casing 1 foot below hole & had welder weld on new 5 1/2", 5.5#, J-55, ST&C casing; tested & held Stubbed surface casing to 1 foot below ground level & backfilled hole. Ran CBL - Emailed to Paul Swartz & Jennifer Mason. Ran MIT to 580 psi - held for 35 minutes.


