Legacy will recover the injection line from the subject well. The injection line runs along existing roads from the well's location in 10(B)-14S-31E to the DQSU TB #3 located in 16(A)-14S-31E. An injection line will then be installed along existing roads from the DQSU TB #1 located in 3(F)-14S-31E to the well. The injection line will follow an existing road southeast roughly 800' then go south roughly 3000' past an abandoned well in 3(J)-14S-31E and past the DQSU #25 well in 3(O)-14S-31E to the subject well.
