Conditions of Approval

Operator has proposed DV tool at a depth of 4000'. Operator is to submit sundry if DV tool depth varies by more than 100' from approved depth.

1. The minimum required fill of cement behind the **9-5/8** inch intermediate casing is:

a. First stage to DV tool:

- Cement to circulate. If cement does not circulate, contact the appropriate BLM office before proceeding with second stage cement job. Operator should have plans as to how they will achieve circulation on the next stage.

b. Second stage above DV tool:

- Cement to surface. If cement does not circulate, contact the appropriate BLM office. **Wait on cement (WOC) time for a primary cement job is to include the lead cement slurry due to potash.**
