*Chevron is in the process of obtaining a surface lease with Oliver Kiehne in Section 21-26-33 for the staging area for drilling trailers and facilities equipment (due to H<sub>2</sub>S). The lease should be finalized by 11-20-2014. Then, it might take approximately two weeks to lay caliche and build a fence. In the meantime, Chevron will be placing 3 trailers and facilities equipment to be used for the Salado Draw development area on the Porter Brown well site.*
