5/28/14 - Set RBP at 6,597 ft. Set packer at 6,565 ft. Loaded tubing with 11 bbls 3 percent KCL and tested RBP to 1500 psi. Held good for 10 mins. Bled off pressure and loaded casing with 30 bbls 3 percent KCL. Tested to 500 psi. Lost 10 psi in 10 mins. Bled off pressure and TOOH with packer. Loaded casing with 15 bbls 3 percent KCL. Perforated Delaware 6,489 ft to 6,498 ft (6 holes).


5/29/14 - Spotted 84 gallons 7.5 percent NEFE acid across perfs at 6,489 ft to 6,498 ft. Acidized with remaining 1416 gallons 7.5 percent NEFE acid.

6/1/14 - Released RBP and POOH.

6/2/14 - Circulated 130 bbls 3 percent KCL. Tested annulus to 500 psi, lost 30 psi in 30 mins. Bled off pressure.

7/21/14 - Frac'd with a total of 191,763 lb 20/40 Jordan Unimin and 16/30 Super LC sand.

7/23/14 - Tag fill at 6,595 ft. Break circulation with 40 bbls 3 percent KCL. Reverse circulate.

Washed sand down to 6,600 ft. Circulated clean.

7/24-26/14 - Tagged up at 6,600 ft. Bail sand down to 6,620 ft. Could not make any progress.

Tagged up at 6,620 ft. Break circulation with 30 bbls. Drilled sand down to 6,705 ft. Ran free down to 6,722 ft. Tagged sand again and lost circulation. Pumped 100 bbls 2 percent KCL pumping 2.5 BPM. Circulated clean.

7/27/14 - Tagged up at 6,720 ft. Break circulation with 80 bbls 2 percent KCL. Washed down to 6,785 ft. Circulated hole clean. ND BOP. 2-7/8 inch 6.50 lb J-55 tubing at 6,764 ft.
