Cemented stage 1 with 140 sacks 35:65:6 Poz "C" + 10% D020 + 5#/sx D042 + 5% D044 + 0.7% D112 + 0.13#/sx D130 + 0.03% D208 + 0.2% D46 + 0.1% D13 + 0.1% D65 (yld 2.07, wt 12.80). Tailed in with 175 sacks 50/50 Poz "C" + 5% D020 + 5#/sx D042 + 5% D044 + 0.4% D112 + 0.01 gal/sx D177 + 0.2% D46 + 0.1% D65 (yld 1.44, wt 14.20). Dropped bomb. Pressured up to 1000 psi.
