Which would put us beyond our 90 day approval window for the work we previously proposed. Mr. Montgomery refers to the Chambers Federal Wells, but this includes the Wilson Federal #1 also. Cano Petro of New Mexico, Inc. Therefore is seeking an extension of this deadline until January 1, 2015. If anything else should delay their arrival we will obviously communicate that to the Roswell field office, through another Sundry Notice.
