Cemented with 430 sacks Class "C" + 8% D020 + 5#/sx D042 + 5% D044 + 0.1% D065 + 0.7% D112 + 0.13#/sx D130 + 0.2% D046 (yld 2.21, wt 12.8). Tailed in with 180 sacks Class "C" + 0.5% D020 + 5#/sx D042 + 0.2% D046 + 0.13#/sx D130 (yld 1.36, wt 14.8). Circulated 107 sacks to the surface.

11/6/14 - Tested casing start 795 psi ended 715 psi for 30 minutes, ok. WOC 33 hours 45 mins. Reduced hole to 12-1/4 and resumed drilling.
