13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Cano Petro of New Mexico, Inc. is building a Consolidated Tank Battery on the former Tank Battery site for this well. The Consolidated Battery will handle production from 4 separate Federal Leases. To help in transferring fluids and loading them, and allowing contractors to utilize power equipment easily we are proposing to bring electric power from existing secondary power lines South of the Tank Battery into the Battery. The length of this line is about 490' and will be on the Oakson "A" Federal lease. We intend to drop power into a plastic conduit that is buried 30" deep and run right along the West Side edge of an existing lease roadway. No new ground disturbance is anticipated in this construction. We wish to start as soon as approved. Ditching for the line will only be done as needed and the conduit will be covered immediately so that no open trenches will be left at the end of the day. We anticipate the construction of this line to take about 2-1/2 days from power and meter setting to end connections at the battery. This line will be inservice all year long and should be in place for at least 25 years.
