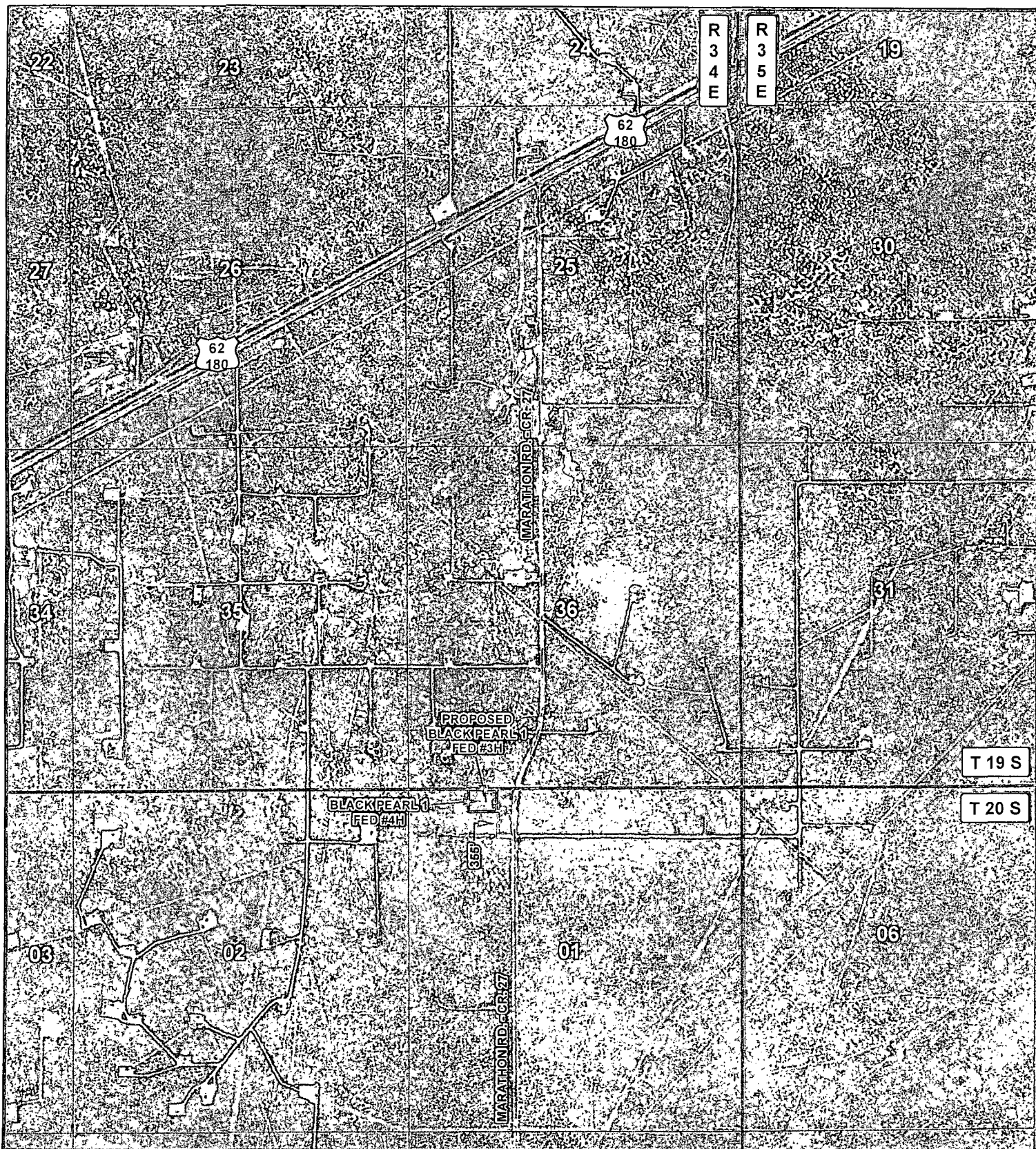


LOCATION MAP TOPO 04/09/2014 S.P.

BLACK PEARL 1 FED FLOWLINE

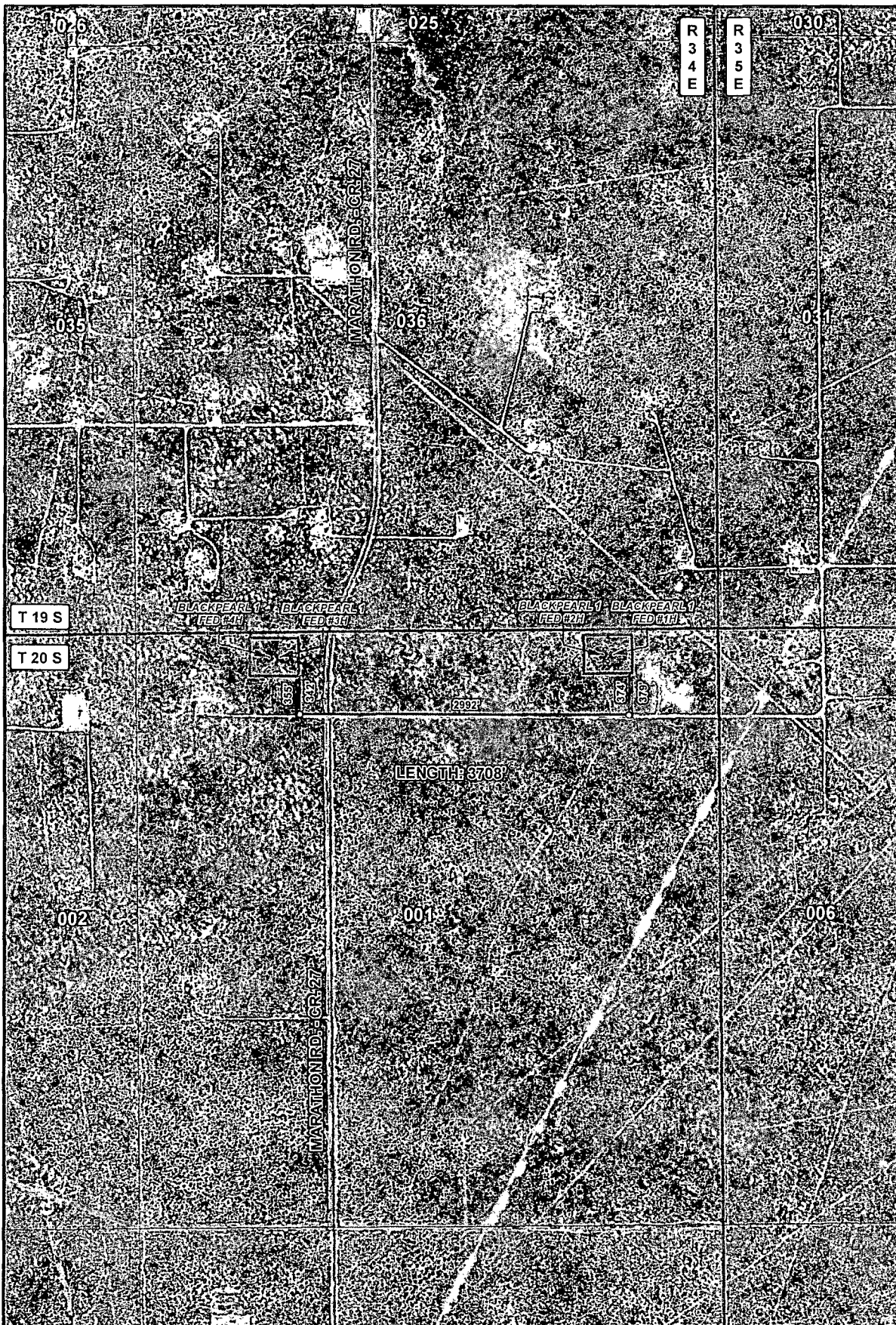
