Devon Energy Production Co. L.P. respectfully requests to continue drilling operations with the 9-5/8" TOC at approximately 80 ft-KB or 50 feet from the wellhead. The surface casing shoe was set at 1,523' which leaves us with 1,473' of cement overlap. The cement job was not able to be remediated due to the FMC Uni-head mandrel not being able to become unseated from the A-section of the multi-bowl wellhead after the cement job. This exhausted any options to run 0.75" or 1" pipe to top the cement job off due to insufficient port sizes on the mandrel. After waiting 24 hours for the cement to set up, we pressure tested the casing to 2,765 psi and the 13-3/8" x 9-5/8" annulus to 500 psi with both test yielding satisfactory results.


