I am going to review your ACOI -274-B. This document expires April 2015 and is online for your review.

ACOI's are created and agreed upon, so that the Operator can work with the State to bring into compliance so many wells before the expiration of the ACOI.

The Langlie Jal Unit #71 has an expired TA Status. If you speak to Maxey Brown or Bill Sonnamaker of our Hobbs Office, they may agree to a pressure test to bring this well back on Approved TA Status. A NOI C103 will be needed if this is the case. Also FYI Daniel Sanchez is the Compliance Manager in Santa Fe.
