- RIH w/open-ended tubing and fill openhole and casing to 2995' w/sand & pea gravel.
- Wash through sand/gravel to 3052'. Spot 50 sx Class C w/2% CaCl₂.
- Drill out cement to PBD at 3077'.
- RIH w/5 jts (210") 4", 11#, L-80 UFJ casing on duplex shoe and cement w/50 sx Class C w/2% CaCl₂. Squeeze TOL, if necessary.
- Drill out to PBD at 3077'. Run injection packer and injection tubing, circulate w/inhibited freshwater, run MIT, and RWTI.
