- MIRU pulling unit. Flange down injection wellhead. Install BOP.
- POH w/ inj pkr and inj tubing. RIH w/ 3 7/8" bit and cleanout suspected casing bridges and wellbore. Fill to 5488' PBD (CIBP @ 5488')
- Spot 275 gal 15% NEFE HCL across perfs 5361'-5478'. RIH w/ 4 1/2" pkr. Acidize perfs w/ 5000 gal 15% NEFE HCL.
- Flow back well until dead.
- RIH w/ new inj pkr and current IPC tubing and on/off tool. Set pkr at 5082'.
- Notify BLM and run MIT casing pressure test to 500# for 30 min.
- Return well to active injection.
