

Pursuant to the BLM letter dated June 9 2014 and received by McClellan Oil Corporation on June 11, 2014 concerning paying quantities of the subject well, please be advised the operator commenced a workover of the well on 11/26/2014.

MIRUPU. Set CIBP at 10,658' and dump bail 35' cmt on top to abandon Morrow perforations 10,668-10,680. Reperf existing Morrow perforations 10,484-90 & 10,584-96 w/ 4 spf, 71 holes. Did not reperf old Morrow perfs 10,606-08. Set pkr at 10,391 and acidize all Morrow perfs w/ 2,500 gal 7 1/2% Morrow HCl acid containing 1,200 ft3 N2 per bbl of acid, AIR 4 BPM @ 3,500 psi. Blow well back to frac tank till dead, RU and swab Morrow, FFL @ SN, no gas show. RUWL and set CIBP at 10,468 and dump bail 35' cmt on top. Morrow abandoned, RDMOPU and prep to swab test existing Wolfcamp perforations 8,429-38 at a later date.
