SEGMENT 1 DESCRIPTION

A strip of land 20 feet wide, being 2812.72 feet or 170.468 rods in length lying in Section 21, Township 21 South, Range 34 East, N. M. P. M., Lea County, New Mexico, being 10 feet left and 10 feet right of the following described survey of a centerline across State of New Mexico Land, with the sidelines being shortened or extended to intersect the Southerly Right-of-Way of existing lease road and the South Line of Section 20:

BEGINNING at Engineering Station 0+00.00, a point on said Southerly Right-of-Way of existing lease road which bears N 88°37'49" W, a distance of 2145.80 feet from a brass cap, stamped "1918", found at the East Quarter Corner of Section 20;

Thence S 15°37'50" E, a distance of 1473.99 feet to Engineering Station 14+73.99, a Point of Intersection (P.I.) with a deflection angle of 04°07'51" to the Right;

Thence S 11°29'59" E, a distance of 135.57 feet to Engineering Station 16+09.56, to a P. I. with a deflection angle of 04°30'26" to the Left;

Thence S 16°00'25" E, a distance of 1203.16 feet to Engineering Station 28+12.72, to the Point of Terminus at the intersection of the South Line of Section 20, a point which bears N 89°20'57" E, a distance of 1228.71 feet from a brass cap, stamped "1918", found at the South Quarter Corner of Section 20.

BEGINNING at Engineering Station 28+12.72, a point on the North Line of Section 29, which bears N 89°20'57" E, a distance of 1228.71 feet from a brass cap, stamped "1918", found at the North Quarter Corner of Section 29;

Thence S 16°00'25" E, a distance of 175.95 feet to Engineering Station 29+88.67, a Point of Intersection (P.I.) with a deflection angle of 73°59'38" to the Left;

Thence N 89°59'57" E, a distance of 1366.23 feet to Engineering Station 43+54.90, to the Point of Terminus at the intersection of the East Line of Section 29, a point which bears S 00°29'38" W, a distance of 185.17 feet from a brass cap, stamped "1918", found at the Northeast Corner of Section 29.

M., Lea County, New Mexico, being 10 feet left and 10 feet right of the following described survey of a centerline across State of New Mexico Land, with the sidelines being shortened or extended to intersect the West Line of Section 28 and the West Line of well pad Chiles 28 State #1H:

BEGINNING at Engineering Station 43+54.90, a point on the West Line of Section 28 which bears S 00°29'38" W, a distance of 185.17 feet from a brass cap, stamped "1918", found at the Northwest Corner of Section 28;

Thence N 89°59'57" E, a distance of 141.20 feet to Engineering Station 44+96.10, to the End of Survey at the West Line of Chiles 28 State #1H, a point which bears S 84°57'24" W, a distance of 2506.34 feet from a brass cap, stamped "1918", found at the North Quarter Corner of Section 28.
