 2. Spot 25sx cmt @ 2400-2500'. P&S @ 2539'. SQZ cmt to 2400' woc Tag
 3. P&S @ 2400', Spot 25sx cmt to 1500'. 1220'. SQZ cmt to 1100' woc Tag (deep penetrating shot)
 4. P&S @ 350', circ cmt in & out of csg to surf. (deep penetrating shots). 3' cmt behind all annulus.
 5. Cut off WH, install dry hole marker.
- At cut-off verify cmt to surf. all annulus.
A closed-loop system will be used to perform this procedure.
