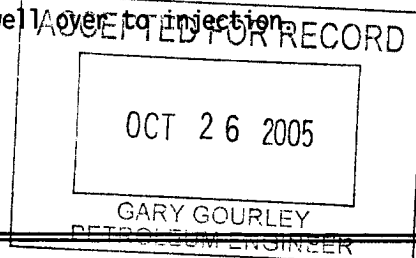

MI x RU. Set cement retainer @ 3947'. Attempt to squeeze perfs from 4014' to 4225' with 600 sx. Premium Plus, but squeeze did not hold. Drill out well from 4238' to 4288'. Run 4.5", 11.6#. ULT-FJ partial liner from 3964' to 4259' and cement with 50 sx. Premium Plus. Perf 4154' - 4240'. 2 spf, 180 degree phasing (66 holes total). Stimulate perfs with 2100 gal. 15% NEFE HCL. RIH with 126 jts. 2-7/8" duo-line injection tubing x Guiberson G-6 packer (pkr set @ 4104'). Load x test casing to 600 psi for 30 minutes (held). RD x clean location. Turn well over to injection.

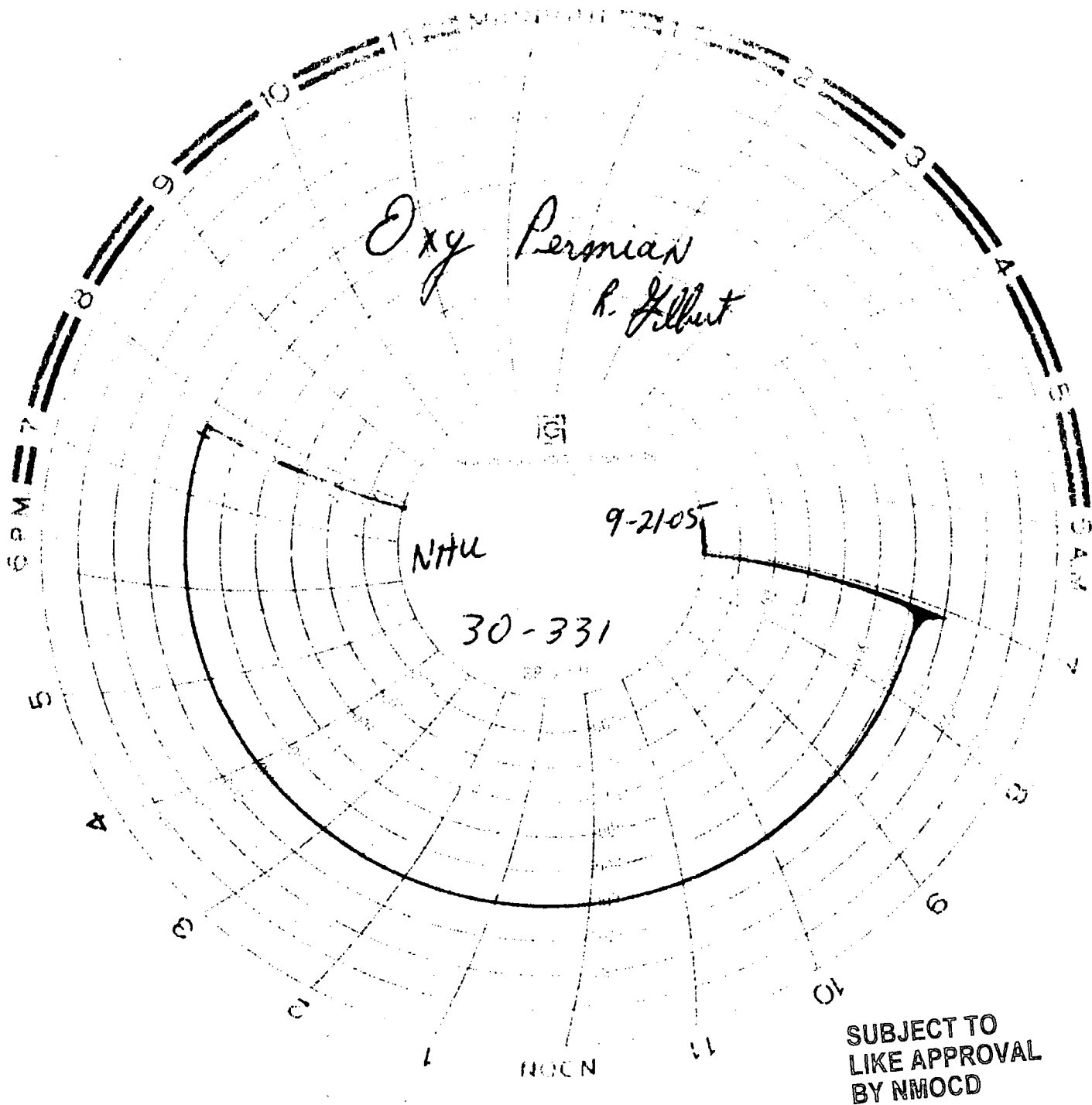
