NEED TO REMOVE CONDUIT, WIRE AND TUBING FROM WEST SIDE OF LOCATION. NEED TO REMOVE CONTAMINATED SOIL AND CINDER BLOCKS ON THE WEST SIDE OF P&A MARKER. NEED TO REMOVE BATTERY WEST OF LOCATION AS THIS IS THE FINAL WELL ON LEASE. ALSO CONTACT GAS PURCHASER AND REQUEST TO TERMINATE SERVICE. BLOCK LINE. AND REMOVE ALL ASSOCIATED EQUIPMENT. A COPY OF THIS CORRESPONDENCE SHOULD BE FURNISHED TO THE OCD. 1ST NOTICE.


