Existing well condition

Perforations from 9480-9510'. Packer @ 9409 stuck in hole. Tubing was cut off @ 9225' and squeezed 115sx from 9200-9510'.

Proposed workover

Propose to set CIBP @ 9180', top with 25sx plug from 8955-9180'. Set 25sx plug from 7340-7550'.

Perforate Yeso from 5318-7100' acidize and frac, put well back on production.
