1. MIRU plugging equipment. POOH with production equipment.
2. Set CIBP at 4000'. Circulate hole with mud laden fluid. Pressure test casing to 500 psi.
3. Spot 25 sx cement on CIBP.
4. Perforate at 1850'. Squeeze with 35 sx cement. WOC and tag. (Shoe plug and top of salt)
5. Perforate at 200'. Pump sufficient cement to circulate cement to surface inside/outside of 4 1/2" casing.
6. Cut off wellhead 4' below ground level. Cut off anchors. Verify cement to surface on all strings. Install below grade P&A marker. (Lessor Prairie Chicken Primary Population Area)

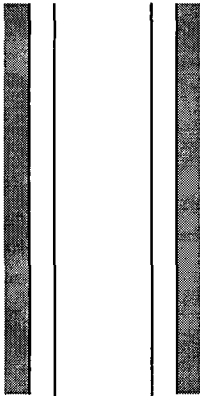

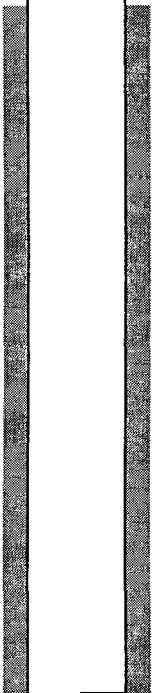
