- MIRU plugging equipment. POOH with production equipment.
- Set CIBP at 4050'. Circulate hole with mud laden fluid. Pressure test casing to 500 psi.
- Spot 25 sx cement on CIBP.
- Perforate at 1930'. Squeeze with 35 sx cement. WOC and tag. (Shoe plug and top of salt)
- Perforate at 200'. Pump sufficient cement to circulate cement to surface inside/outside of 4 1/2" casing.
- Cut off wellhead 4' below ground level. Cut off anchors. Verify cement to surface on all strings. Install below grade P&A marker. (Lessor Prairie Chicken Primary Population Area)


