



HEADING SOUTHEAST ON HWY 128 TURN RIGHT (SOUTHWEST) ONTO CR 2 (BATTLE AXE RD.); THEN GO APPROX. .3 MILES; THEN TURN RIGHT (WEST) AND GO APPROX. 1.6 MILES; THEN TURN LEFT (SOUTH) AND GO APPROX. 1 MILE; THEN TURN LEFT (WEST) AND GO APPROX. .5 MILES; THEN TURN LEFT (SOUTHERLY) AND GO APPROX. 1.5 MILES; THEN RIGHT (SOUTHWESTERLY) AND GO APPROX. 3.4 MILES; THEN TURN RIGHT (SOUTHWEST) AND GO APPROX 2.7 MILES; THEN TIRN LEFT (SOUTH) AND GO APPROX .7 MILES; THEN TURN LEFT (EAST) AND GO APPROX. 1.8 MILES; THEN RIGHT (SOUTH) AND GO .8 MILES; THEN TURN LEFT (SOUTHEAST) AND GO .4 MILES; THEN TURN LEFT (NORTHEAST) AND GO .25 MILES; THEN TURN RIGHT (SOUTHEAST) AND GO .1 MILES AND PROPOSED WELL IS APPROX. 300' SOUTHEAST.
