6/8/15 -

6/9/15: Rig up CRT x run 117 jts 7", 26#, J-55, LT&C casing with 46 centralizers and set at 4623'. RU Halliburton and cement first stage with 210 sx. 14.8 ppg, Cl. C. Bump plug and open DV tool (at 3820'-23') x circulate 95 sx. to surface. Cement second stage with 360 sx. 11.9 ppg, 50/50 Poz Prem. Plus (lead) and 200 sx. 14.2 ppg, 50/50 Poz Prem. Plus (tail). Circulate 70 sx. to surface. Set x tested casing pack-off to 3000 psi x ND BOP. NU wellhead x test to 3000 psi. Jet pits x rig down.
