1. Removed well sign, power poles, meter run, flowline, and all debris
2. Dry hole marker installed with information on it
3. Strip caliche from location and access road
4. Remove any contaminated soil and replace with clean topsoil
5. Contour to surrounding and shape
6. Built an earthen barricade at entrance to prevent vehicular traffic
7. Rig and seed all disturbed areas with BLM seed mixture # 3.




