Cimarex Energy Co. of Colorado would like to respectfully request permission to lay a 4", buried, high pressure (MAOP of 1500, working pressure of 1200 max) flexpipe water injection line from the Bondurant Federal 10 battery to the Bondurant Federal Com 2 (Sec. 1, T19S, R32E, SE/NE 1650' FNL and 330' FEL). We are planning on converting the Bondurant Federal Com 2 into a SWD well.

The line leaves from the North side of the Bondurant Fed 10 pad, heads South and then East to the Bondurant Fed Com 2 all along existing disturbance. The approximate footage for this project will be 2525.44', 153.057 rods, or 1.739 acres and is all on lease NMNM012568A. Please see attached plats.



DESCRIPTION

A strip of land 30 feet wide, being 2,525.44 feet or 153.057 rods in length, lying in Section 1, Township 19 South, Range 32 East, N. M. P. M., Eddy County, New Mexico, being 15 feet left and 15 feet right of the following described survey of a centerline across B. L. M. land:

BEGINNING at Engr. Sta. 0+00, a point in the Northeast quarter of Section 1, which bears S 10°58'21" W, 1,679.75 feet from a 1/2" rebar, found for the Northeast corner of Section 1.

Thence S 62°42'27" W, 183.40 feet to Engr. Sta. 1+83.40, a P. I. of 59°30'24" right;

Thence N 57°47'09" W, 104.65 feet to Engr. Sta. 2+88.05, a P. I. of 13°34'21" right;

Thence S 88°48'40" W, 86.12 feet to Engr. Sta. 25+25.44, the End of Survey, a point which bears S 75°26'19" E, 3,476.35 feet from a brass cap, stamped "1912", found for the Northwest corner of Section 1.
