Bump plug and open DV tool (@ 4445'-49') x circulate 99 sx. to surface. Cement second stage with 360 sx., 11.9 ppg, Cl. C (lead) and 330 sx., 14.2 ppg, Cl. C (tail). Circulate 138 sx. to surface.
