Legacy Reserves requests another 1-year temporary abandonment status on the subject well.

Due to low oil prices we cannot perform the planned work on this well to return it to active production. However, we do not wish to PXA this well as the additional cost to re-enter this well will likely make this work uneconomical to do in the future.

Our future plans are to plugback this well back from the Blinebry-Tubb-Drinkard to the Blinebry, acidize and frac stimulate the Blinebry and install an ESP. Our estimated cost is \$280,000 to perform this work. This work is not economic at the current \$45-55 oil price range as we are being paid in 2015, to date.
