We ran and cemented our 11-3/4" casing to surface with no issues but when going to set the slips we were unable to get them to set in the A-section of the wellhead. After discussions with Wesley Ingram with the BLM we were given a verbal approval at 2000 hours New Mexico time on July 25th to cut off the original A-section, weld a new 11-3/4" A-section onto the intermediate casing and monitor the annulus by doing the following:
?Operator needs to weld a steel plate across the open annulus, install a nipple, with a 2" ball valve. A gauge should be installed in the downstream end of the valve. While drilling, the pressure shall be checked and recorded every eight hours. When the well actually becomes a producer, operator shall not only have a gauge, but shall connect it to either a WellKeeper or Scada system.
The steel plate has been welded on with required equipment and we are monitoring the pressure every 8 hours in the drilling reports.
