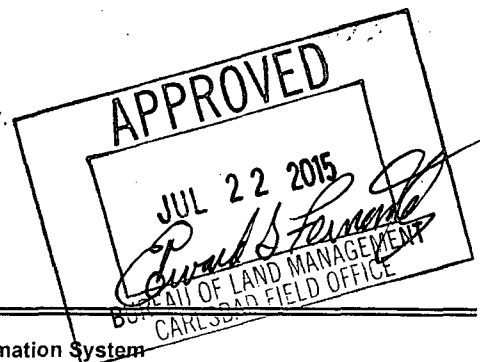

3. Swab or jet the well w/N2 to restore production.
