Please notify the proper district office of the Division, in writing, of the date corrective actions are scheduled to be made so that arrangements can be made to reinspect the well and/or facility.



NEED TO COMPLETE RESTORATION AND SUBMIT CI03 WHEN WORK IS COMPLETED. PLEASE INCLUDE COPIES OF CORRESPONDENCE TO POWER PROVIDERS AND GAS PURCHASERS REQUESTING REMOVAL OF THEIR EQUIPMENT.


