We propose to test Two zones to determine the presense of Behind Pipe Reserves. These zones will be perforated, acidized with 1500 to 2500 gallons of 7.5% NEFE acid and swab tested separately. If Swab tests idciate the necessessity for further stimulation, the zones will be fracked using 30,00 to 60,000 # of sand pursuant to service company reccommendation.


