13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. We propose to drill out the CIBP @ 5880' and clean the hole out to the original PBTD of 6213'. After cleaning the hole out we propose to test one zone to determine the presence of behind pipe reserves. This zone will be perforated, acidized with 1500 to 2500 gallons of 7.5% NeFe acid and swab tested. If swab tests indicate the necessity for further stimulation, the zone will be fracked using 30,000 to 60,000 # of sand pursuant to service company recommendation.

Proposed new perforation:

Zone 1: 5524' - 5575'

We expect this job to last approximately 2 weeks and the work is scheduled to begin between April 6, 2015 and June 30, 2015.


