8/12/15: RU CRT x run 138 jts. 7", 26#, J-55, LT&C casing with 83 centralizers and set at 5520'. RU Halliburton x cement first stage with 240 sx., 14.8 ppg, Cl. C. Bump plug and open DV tool (@ 4620'-4624') x circulate 125 sx. to surface. Cement second stage with 410 sx., 11.9 ppg, Cl. C (lead) and 310 sx., 14.2 ppg, Cl. C (tail). Circulate 84 sx. to surface. Set x tested casing pack-off to 3000 psi x ND BOP equipment. NU wellhead x test to 3000 psi. Jet pits x rig down.
