Bump plug and open DV tool (@ 4023'-4027') x circulate 147 sx. to surface. Cement second stage with 370 sx., 11.9 ppg, Cl. C (lead) and 230 sx., 14.2 ppg, Cl. C (tail). Circulate 104 sx. to surface. Set x tested casing pack-off to 3000 psi x ND BOP equipment. NU wellhead x test to 3000 psi. Jet pits x rig down.
