 6/22/15 - RIH with gauge ring/junk basket to 6,100 ft and POOH. Set 5-1/2 inch RBP at 6,000 ft.
 6/24/15 - Tied onto 5-1/2 inch X 9-5/8 inch annulus pumped 100 sacks lead cement 12 lb PVL with fluid loss followed by 650 sacks 12 lb PVL. Pumped 2 bbls fresh water to clear lines.
 6/29/15 - Ran Radial, CCL, GR log from 5,946 ft up to the surface with 1500 psi. TIH with 2.875 inch tubing, latch onto RBP and released RBP. TOC at 400 ft.
 7/1/15 - TOH with RBP and TIH with sub pump equipment. Set 2-7/8 inch 8.60 lb L-80 tubing at 10,365 ft.
