03/03/15 Tagged plug @ 915'. POH w/tbg. Set packer @ 30' and pressure tested csg to 500 psi. Held. Perf'd csg @ 350'. Sqz'd 115 sx cement and circulated to surface. Rigged down and moved off.
03/05/15 Moved in backhoe and welder. Dug out cellar. Cut off wellhead. Welded on "Above Ground Dry Hole Marker". Removed anchors and cleaned location. Moved off. Installed Closed-Loop System with steel tanks. Hauled contents from Closed-Loop System to approved NMOCD disposal location according to Rule 19.15.17.
