03/03/15 Dug out cellar. ND wellhead. NU BOP. POH w/107 jts IPC tbg and packer. Set 5 1/2 CIBP @ 3200. Circulated hole w/mud laden fluid. Spotted 45 sx cement @ 3200-2756. POH w/tbg.
03/04/15 Tagged plug @ 2800'. Pressure tested csg to 500 psi. Held. Perf'd casing @ 2700'. Pressured up on perfs to 600 psi. Spotted 30 sx cement @ 2750-2454. WOC. Tagged plug @ 2630'. Re-spotted 25 sx cement @ 2630-2383 (per Jack Johnson w/BLM). WOC.
03/05/15 Tagged plug @ 2395. Perf'd casing @ 1300'. Set packer @ 984 and sqz'd 35 sx cement. WOC. Tagged plug @ 1100'. Perf'd casing @ 325'. Sqz'd 120 sx cement and circulated to surface. Riggged down and moved off.
03/11/15 Moved in backhoe and welder. Dug out cellar. Cut off wellhead. Welded on "Above Ground Dry Hole Marker" per BLM specs. Removed deadmen. Cleaned location and moved off.
Installed Closed-Loop System with steel tanks. Hauled contents from Closed-Loop System to approved as to plugging of the well bore. Liability under bond is retained until Surface restoration is completed.
