Ownership is the same in the Tubb/Drinkard; different for the Blinebry. Allocation will be based on 160 acres for the Blinebry as per NMOCD Order No. R-10986-A and on 40 acres for Tubb/Drinkard as per NMOCD pool rules. Notification by Sundry Notice is being sent to all ownership.

Proposed Allocation based on historical and current data: Blinebry - oil: 20%; gas: ~~35.9%~~ ^{36%}; water: 40%. Tubb - oil: 20%; gas: ~~44.9%~~ ^{45%}; water: 40%. Drinkard/~~450~~ - oil: 60%; gas: ~~19.2%~~ ^{19%}; water: 20%. This commingling will not lessen the value of this well, but will maximize production and prevent waste.

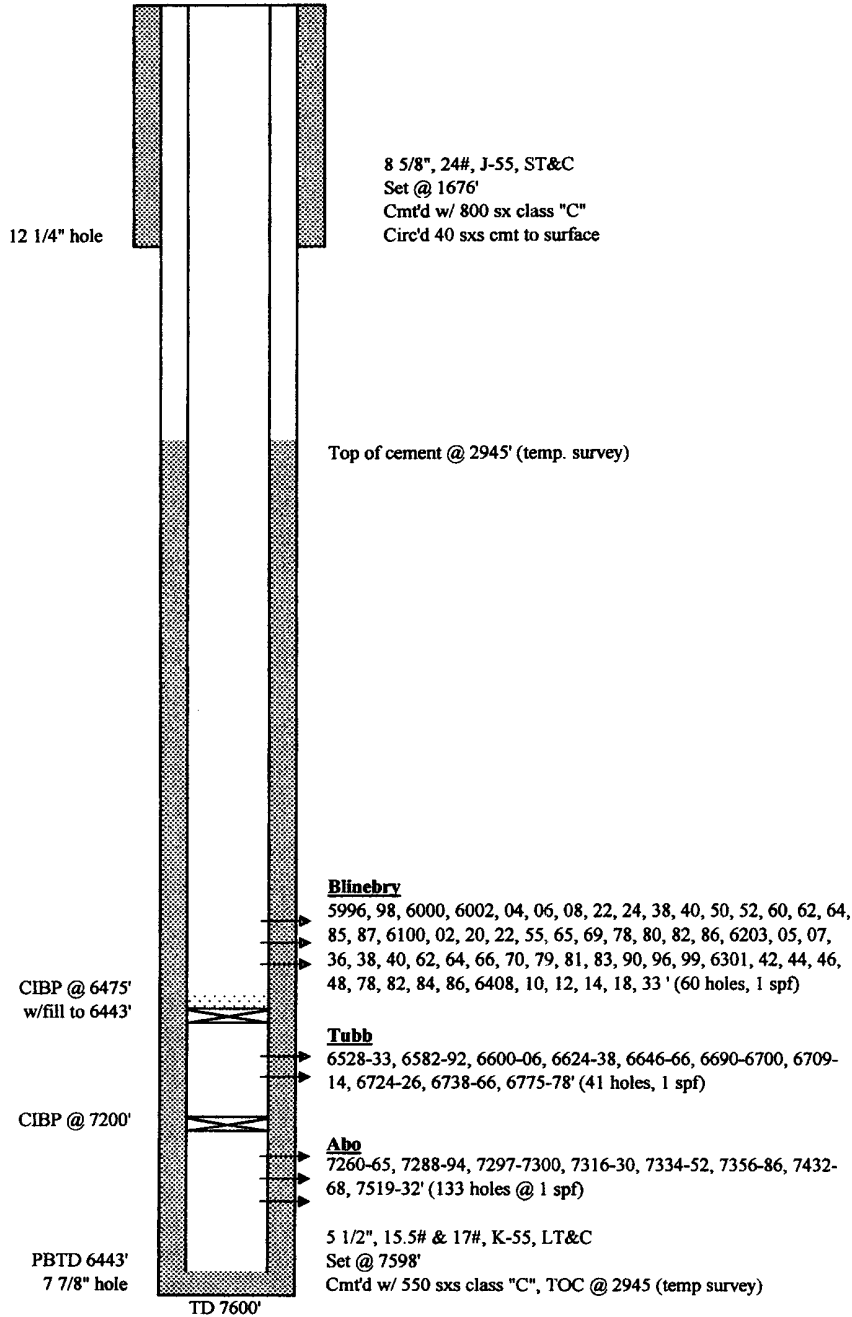

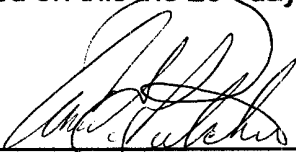
