THIS ANNULUS WAS SQUEEZED DOWN THE BRADENTHEAD WITH 130 SACKS OF CLASS C NEAT CEMENT TO 1700#. (10/18/05). THIS WELL PASSED ITS MIT TEST ON 11/9/05. (CHART ATTACHED)

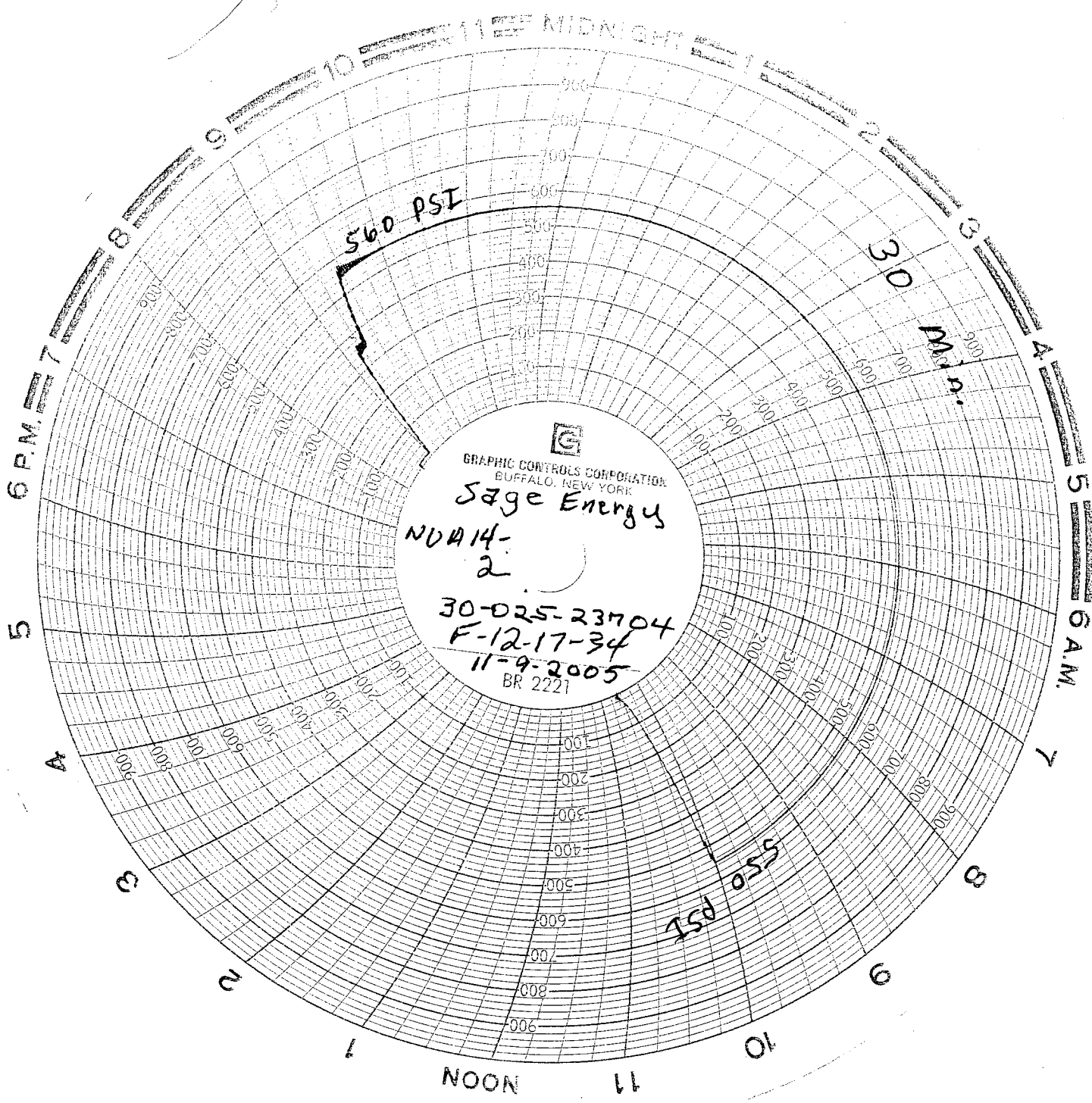
