10-19-05: Reached total depth of 4175'. Ran 5 1/2", 15.5#, J-55 casing to 4175'. Cemented with 600 sx lead 50/50 Poz C, 10% gel + 5% salt, .125 CF, 3# LCM1, tailed with 250 sx 50/50 Poz C, 2% gel 5% salt. Plug down. Floats held OK. Cement circulated to pit. WOC.
