10-24-05 Set composite BP @ 8750'. Perf Lower Brushy Canyon (Delaware) w/ 2 SPF, 8520' - 8533' (13'). 27 total holes.

10-25-05 Acidize w/ 1000 gal 7-1/2% acid and 50 BS. Swab well.

10-28-05 Frac Delaware (8520' - 33') w/ 32,000 gal X-linked gel w/ 16/30 Ottawa sand & 20,000# resin coated sand. Swab well.

11-1-05 RIH w/ tbg.

11-2-05 RIH w/ pump & rods.

11-7-05 Turn to production.
