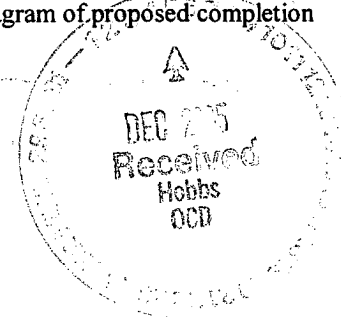

11/25/05: MI x RU. Spud 12-1/4" hole at 4:00 p.m. (NMOCD notified)

11/26/05 -

11/27/05: RU casing crew. Run 36 jts. 8-5/8", 24#, J-55, ST&C casing with 10 centralizers and set at 1550'. RU Halliburton and cement with 450 sx. Premium Plus (lead) and 300 sx. Premium Plus (tail). Circulate 165 sx. to surface. WOC 4 hours. Cut off casing and weld on wellhead. NU BOP and test blind rams and choke manifold to 1200 psi. Test pipe rams and hydril to 1200 psi. Drill out cement and resume drilling operations.
