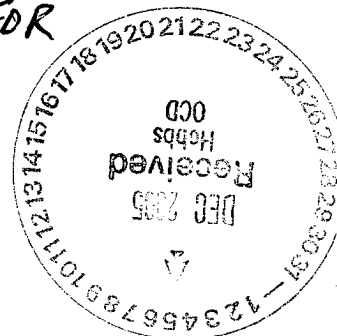

This well was TA'd w/ CIBP set @ 4563' on 06/16/1999. Per the attached integrity test-chart performed on 11/15/2005, this well failed its re-test for continued TA Status. Pure Resources, L. P. respectfully requests an extension of time with Temporarily Abandoned Status of this wellbore to acquire AFE/WIO approvals, bidding well pluggers, scheduling rig and acquiring OCD approved P&A C-103. This will allow for properly planning, proposing and executing permanent Plug and Abandonment of this wellbore.

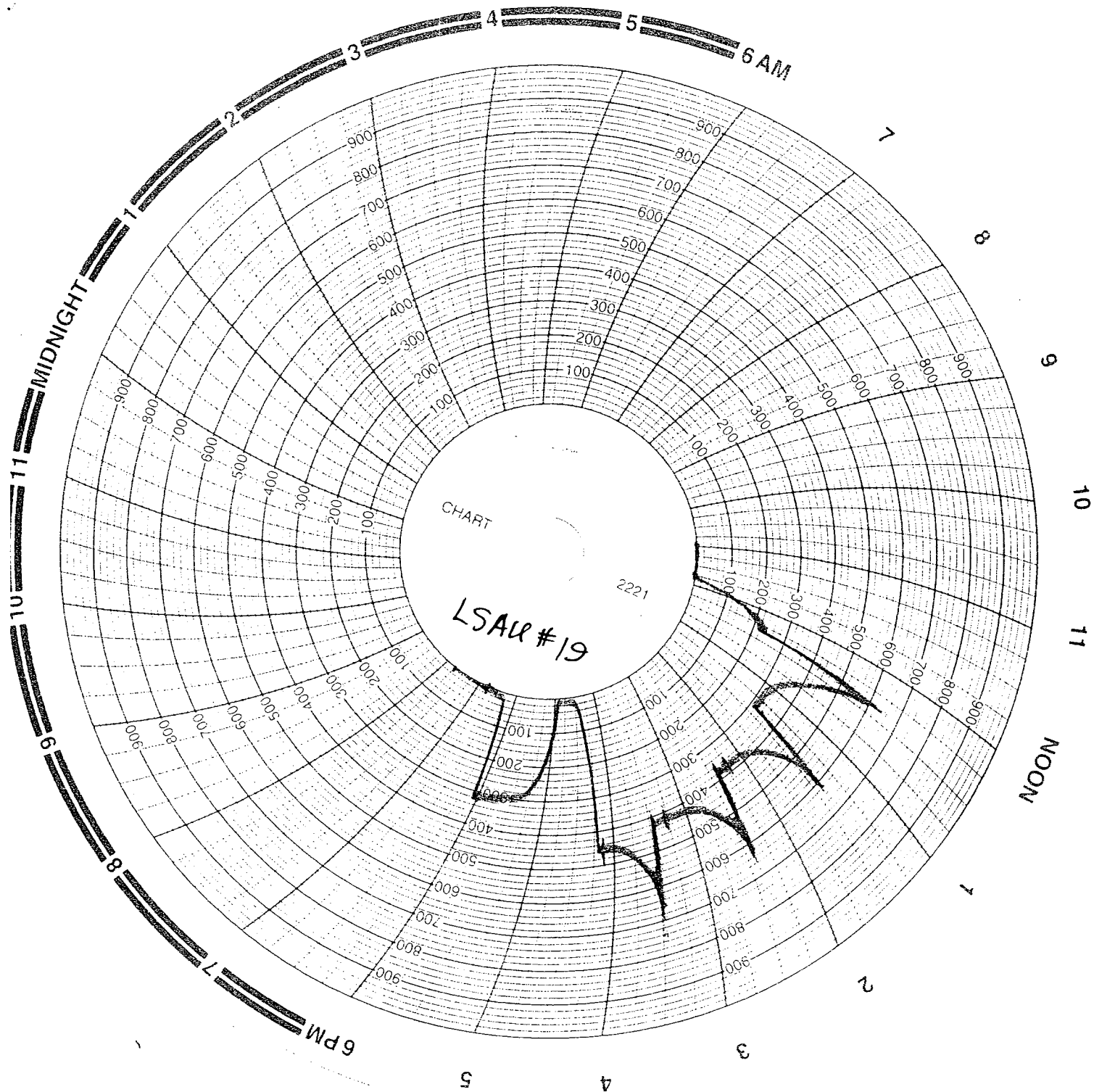
