Notified BLM. Set steel working pit. MIRU Triple N plugging equipment. ND wellhead & NU BOP. POOH w/ production equipment. RIH w/ 5 1/2" HM tbg-set CIBP. RU cementer and set CIBP @ 4,218'. Circulated hole w/ mud and pumped 25 sx C cmt on CIBP 4,218 - 3,972'. PUH to 3,915' & pumped 25 sx C cmt 3,615 - 3,668'. J.R. Hogwood w/ BLM on location. RIH w/ wireline and perforated casing @ 1,950'. RIH w/ packer to 1,550'. Loaded hole, set packer, established rate of 1 BPM @ 250 psi (full returns to surface), and squeezed 75 sx C cmt w/ 2% CaCl2 1,950 - 1,650'. RIH w/ wireline, tagged cmt @ 1,650', POOH w/ wireline. ND BOP, pumped 10 sx C cmt 60' to surface. Cut off wellhead and anchors, install dry hole marker, & level location. Leave location clean and free of trash.
