09-20-05 Spudded 17-1/2" hole.

09-21-05 Ran 10jts 13-3/8" 48# H-40 STC casing to 425'. Cemented with 20bbls spacer and lead of 260sx Premium Plus + 4% Bent + 2% CaCl2 + 0.25# Flocele @ 13.7 wt and 1.68 yield. Cemented with tail of 150sx Premium Plus + 2% CaCl2 @ 14.8 wt and 1.34 yield. Circulated 167sx to pits. WOC 25.5 hours.

09-22-05 Pressure tested casing to 1000psi for 30 minutes.

09-29-05 In 12-1/4" hole, ran 79jts 9-5/8" 40# J-55 LTC casing to 3490'.

09-30-05 Cemented with 20bbl spacer and lead of 880sx Interfill C + 0.25# Flocele @ 11.9 wt and 2.45 yield. Cemented with tail of 200sx Premium Plus + 1% CaCl2 # 14.8 wt and 1.33 yield. Did not return cement to surface. Ran temperature survey to find TOC at 260'. Performed a one-inch top job by topping out the 13-3/8" X 9-5/8" annulus with 80sx Premium Plus Neat @ 14.8 wt and 1.33 yield. Tested casing to 2000psi for 30 minutes. WOC 24.25 hours.
