12/3/05: Drill to TD at 4441'. RU casing crew and run 104 jts. 5-1/2", 15.5#, J-55, LT&C casing with 10 centralizers and set at 4441'. RU Halliburton and cement first stage with 250 sx. Premium Plus. Bump plug, drop bomb, and open DV tool. Circulate 42 sx. to surface. WOC and circulate between stages. Cement second stage with 450 sx. Class 'C' (lead) and 100 sx. Premium Plus (tail). Circulate 30 sx. to surface. ND BOP x set casing slips. Cut off casing and install tubinghead. Jet and clean pits and RD.

Release drilling rig at 9:00 a.m., 12/3/05.
