POOH w/ 144 jts 2 3/8" tubing & TAC. RU wireline and RIH w/ CIBP, stacked out @ 124' in paraffin. RD wireline and RIH w/ 144 jts tubing. Notified NMOCD, Gary Wink. Replaced transmission on cementer. RU cementer and set CIBP @ 4,400'. Circulated hole w/ mud, pumped 25 sx C cmt on CIBP @ 4,400'. POOH w/ 30 stands tubing, will tag in am. RIH w/ tbg and tagged cmt @ 3,900'. POOH w/ tbg to 3,151' and pumped 25 sx C cmt 3,151 - 2,783'. POOH w/ tubing to 1,903' and pumped 25 sx C cmt w/ 2% CaCl₂ @ 1,903'. POOH w/ tbg and WOC 3 hrs.
