Pumped 25 sx C cmt 2,125 - 1,884'. Cut casing @ 1,448', not free, unable to pump thru cut at 1,500 psi. Pumped 25 sx C cmt @ 1,487'. WOC & tagged cmt @ 1,112'. Cut & pulled 5 1/2" casing FROM 856'. RIH w/ tbg and pumped 35 sx C cmt w/ 2% CaCl₂ @ 896'. WOC and tagged cmt @ 730'. Circulated 55 sx C cmt 216' to surface. POOH w/ tbg, ND BOP. RDMO.
